


Family Violence: Georgia Statistics & Trends



FAMILY **VIOLENCE** is a pattern of abusive behavior in anv relationship that is used by one partner to gain or maintain power and <u>control</u>over another intimate partner.¹

From 2018-2021 there were 171,596 171,596 reported incidents of family violence in Georgia.²



There were 42,285 incidents of family violence reported in Georgia during 2021.²

- There was a 2.5% decrease in family violence incidents reported to law enforcement 2.5% from 2018-2021.² In 2021, 69% of victims in family violence incidents reported to law enforcement 69%
 - were female and 30% were male.²
- In 2022, there were 129,528 crisis calls to Georgia's certified family violence and 129,528 sexual assault agencies, a 13% increase from 2021 crisis calls.³
- There were 17,682 family violence and stalking Ex Parte Temporary Protective 17,682 Orders (TPOs) issued in 2022.⁴
 - In 2022, the overall "extension rate," or the rate at which Ex Parte (emergency) TPOs were extended into a longer-term TPO (6-month, 12-month, 3-year), was 41%.4
 - In 2022, firearms were the cause of death in 81% of all family violence-related fatalities.5

Known domestic violence fatalities in Georgia totaled 1,720; a 42% increase from 2012–2022.⁵



There were 193 known domestic violence fatalities in Georgia during 2022.⁵

National Statistics

Over their lifetime, 1 in 5 of women and 1 in 7 men experience severe physical violence by an intimate partner.⁶



Over their lifetime, 1 in 3 (31%) women and 1 in 6 (16%) men have been stalked by an intimate partner placing them in fear for their own life or the lives of those close to them.⁶



Around half of the women visiting emergency departments report a history of abuse, and about 40% of those killed by their abusers had sought help in the two years before their death.⁷



The presence of a gun in domestic violence situations increases the risk of homicide by 500%.⁸



Georgia ranks fourth in the nation for murder-suicide incidents.⁹
