Participant Contract	<ul> <li>This contract must include:</li> <li>Details of program structure including: class fees, victim liaison fees, state fees, orientation terms, 90 minute classes, and 24 weeks of classes;</li> <li>Participant's loss of confidentiality;</li> <li>Victim's right to leave the relationship;</li> <li>Nonviolence agreement;</li> <li>Removal of all weapons from home;</li> <li>Abstinence from alcohol and drugs; and</li> <li>Non-compliance and termination protocols</li> </ul>	
Participant Completion and Termination Form	This template (or templates) must include:  Referral source, Participant's name, and Completion date of the program or the date and reason for termination	
Victim Liaison Contract	This contract must include:  • Payment terms and • Signatures of the victim liaison's director and the FVIP owner/director  View list of certified domestic  violence shelters	
General Liability Insurance Form	This document must include:	
Owner's Secure and Verifiable Document	<ul> <li>New: Upload a copy of the owner's secure and verifiable document that does not expire during the certification period</li> <li>Renewal: Non-U.S. citizens must upload a copy of the owner's secure and verifiable document annually</li> <li>View list of acceptable documents</li> </ul>	
Owner's Affidavit of Lawful Presence	<ul> <li>New: Upload the owner's signed, notarized affidavit</li> <li>Renewal: Non-U.S. citizens must upload the owner's signed, notarized affidavit annually</li> </ul> Download blank affidavit	
Locations	<ul> <li>New: List at least one location where you plan to hold classes</li> <li>Renewal: List at least one location where you hold classes; classes must be at least 90 minutes in duration</li> </ul>	
Staff List	Employ at least one person who meets all facilitator requirements	
Payment (Credit Card or Check)	\$150 for each judicial circuit where classes are held

Coordinated Community Response/Task Force Hours (Facilitators Only)	<ul> <li>New: 40 hours of participation in coordinated community response, which may include:         <ul> <li>Local task force meetings,</li> <li>Task force development,</li> <li>Victim advocacy, or</li> <li>Volunteering with local domestic violence shelters</li> <li>View list of family violence task forces</li> </ul> </li> </ul>	
	Renewal: 4 hours annually of participation in coordinated community response	
Continuing Education Hours (Facilitators Only)	<u>New</u> : 40 hours of GCFV-approved training <u>View list of GCFV-approved training</u>	
	Renewal: 8 hours each calendar year of GCFV-approved training     View list of GCFV-approved training	
Experiential Education Hours (Facilitators Only)	<ul> <li>New: 4 hours of experiential education, which may include:         <ul> <li>Traveling with police on family violence cases,</li> <li>Attending court during domestic violence cases, or</li> <li>Observing probation/parole officers that supervise family violence probationers</li> </ul> </li> </ul>	
<b>Degree</b> (Facilitators Only)	Undergraduate degree or at least 2 years of equivalent experience involving batterers and victims or victim advocates	
Background Information (Facilitators Only)	<u>New</u> : Completed and signed background check authorization form and information related to any criminal offense committed	
	Renewal: Information related to any criminal offense committed in the past 2 years
