2017 Fatality Review Report

This year, the Georgia Domestic Violence Fatality Review Project's Annual Report focuses on the problem of intimate partner stalking. Intimate partner stalking is a dangerous and prevalent problem that often has devastating impacts on victims. Four percent of women and two percent of men are stalked each year in the United States, meaning that roughly 312,000 Georgians are stalked each year. Despite the staggering statistics, stalking that occurs in the context of intimate relationships is a largely invisible crime that often goes without consequences for the perpetrator.

Through exploring the issues of intimate partner stalking, we hope to examine some key questions: How is stalking a precursor to homicide? What is different about domestic violence homicides involving stalking behaviors? If there is something different, how can we make changes to prevent future deaths? Are we missing opportunities to take stalking behaviors more seriously and hold perpetrators accountable? If so, how can we fill in these gaps to provide interventions and services to ultimately keep victims safer? Our analysis of reviewed stalking cases revealed several key findings and recommendations to address those questions, which are discussed throughout the Annual Report.
